If You Want a Say, Vote Yes on Proposition J

On Tuesday, November 6, 2018, you can reaffirm your right to review and approve the City's next comprehensive revision of the land development code by voting "Yes" on Proposition J. Proposition J is the CodeNEXT citizen petition initiative. If Austin voters approve Proposition J, then before CodeNEXT (or a substitute comprehensive revision of the land development code) can become law, there will be a waiting period and voter approval requirement.

It will take the prospect of a public vote on the revised code to get the Council to... work with the community towards a consensus.

Proposition J's waiting period and voter approval requirements apply to "comprehensive revisions of the land development laws". Comprehensive revisions are once in a generation complete overhauls of a City's land development laws such as in 1985 and as proposed with CodeNEXT. Opponents have claimed that Prop. J would "hogtie" the city and prevent code improvements. Not true. Proposition J does not require a waiting period or voter approval for specific land development projects, targeted improvements to the Code, public works projects, or the enactment of new programs (such as flooding mitigation, new environmental standards or affordable housing) because those are not comprehensive changes to zoning districts across the city as CodeNEXT proposed.

When CodeNEXT was "suspended" by the Council in August, the Council indicated that they intended to restart a comprehensive land development code revision (probably under a different name) after the November 2018 election. The Council chose ballot language for Prop J that suggests a waiting period as long as three years after adoption for a comprehensive revision. That is misleading. Under the City's timeline, any waiting period would likely be about a year or less after adoption. In fact, the waiting period can be shortened or even eliminated if this time around the Council does its job and adopts a code reflecting a community consensus. In all likelihood, it will take until the summer of 2020 to create a new process, hold hearings and pass a revised code – if it is done the right way, that is, from the ground up, not imposed from the top down. The Council can amend Proposition J, including modifying the waiting period, by a 3/4 vote majority a few months later in November of 2020. So the effective date of the revised code can be almost immediate if there is strong support for the document. But it will take the prospect of a public vote on the revised code to get the Council to stop dictating, start listening and work with the community towards a consensus.

Council Resolution on Crestview Austin Energy Site By Anne-Charlotte Patterson, CNA Vice-President

On November 1st, the Austin city council will vote on a resolution recommending re-development of a city-owned lot at 6909 Ryan Drive at Justin Lane currently used by Austin Energy for storage. The resolution language is based largely on a report by a CNA working group. The group's recommendations call for a mixed-use development that includes amenity-rich park space, affordable housing, and easy pedestrian access from the neighborhood to the Crestview Metrorail station. The recommendations were based on comprehensive neighborhood survey data.

Howdy Neighbor

Election time is here! In my former career, I'd be neck deep in stats and guiding resources until the last minute to try and increase voter turnout where it was most helpful for my candidates. This year though, it looks like there could be record levels of participation so most candidates are just hustling to raise their "Name ID" so that when all of us go to the polls they have a shot at beating the incumbents in what will most certainly be what we would call a "change election".

Incumbents are hard to beat. They usually have more cash on hand and an easier time getting more. Most lobbyists and industries reliant on government have a de-facto "friendly incumbent" rule. It's always easier to get on a winner's late train than risk upsetting entrenched power.

Speaking of entrenched power, don't forget to vote in the city elections allIllI the way down to the bottom of the ballot. Believe it or not, there is as much as a fifty percent drop-off in votes between the top and bottom of the ballot. This is another factor that plays in the favor of incumbents in local races.

This year we have an opportunity to elect a mayor that doesn't want to turn our neighborhood from single family to a "transition zone" with far fewer rules around the size and density of what can be built next to you. Your property taxes go up every time a house on your block is torn down and bigger, multiple luxury units are put up. Our current zoning already allows for ADUs (granny flats), duplexes and other forms of increased density. It is one of the things that makes our neighborhood housing stock so interesting and varied.

Developers still salivate over our neighborhood because our dirt is still considered cheap enough to make a decent

buck on a flip, and the mayor's appointees to the planning commission seem all too eager to help by pushing for more upzoning.

This was a major factor in the Austin Neighborhoods Council's recent endorsement of Laura Morrison for mayor.

Recently, a study of Austin's new apartment construction said that 88% of new builds were considered luxury apartments. Another study also showed that we are on track to well surpass the stated number of units needed in the next decade. Kinda makes you wonder what all this hullabaloo is about if it isn't really about affordability or a perceived housing crisis. It's just an effective real estate marketing tool. The fact is that between the costs of labor and materials on a sharp rise, in conjunction with our ever rising salary base, there will never be any affordable housing built that isn't subsidized.

Finally, I'm writing this on my way to Oktoberfest. I hope you enjoyed it, and as always, "Thank you, Nancy Barnard" for organizing such a fun event for such a great cause (Brentwood Park)!

Only with this electoral accountability will we get a new code that is driven by facts, that keeps promises and respects rights. Only in this way will we get a new land development code that will be fair to all neighborhoods in all areas of town, that reflects genuine consensus and that allows us to shape the future, not surrender to it. Only in this way will we get a say about the future of our homes, our neighborhoods, and our city.

It took hundreds and hundreds of hours of detailed study to discover and expose the truth about CodeNEXT buried in reams of paper and obscured by the City's public relations presentations and consultant jargon. It took 31,000 signatures. It took a lawsuit and a victory in court.

You earned the right to vote; now it is time to preserve that right to vote. On November 6th we make it formal. Vote "yes" to Proposition J to vote on CodeNEXT or its replacement. Vote "yes" to forge a community-based consensus.



In Memoriam - Todd Bol, Founder of Little Free Libraries

Mr. Bol, whose streetside memorial library provided the inspiration for Little Free Library, a nonprofit that he grew into a network of more than 75,000 tiny, whimsical book exchanges that encourage passersby to "take a book, leave a book," died of pancreatic cancer on Oct. 18 at a hospice center in Oakdale, Minnesota.

In what he later described as "a spiritual gesture" to his late mother, Todd set to work one day in 2009. Repurposing wood from his garage, he built a dollhouse-size library in the

shape of a one-room schoolhouse complete with with a steeple and a tiny toy bell.

He said he began to realize the potential of the little library when his wife hosted a garage sale in 2010, and more people seemed interested in examining his library and discussing its books than in perusing the Bol family's knickknacks.

There are now Little Free Libraries in all 50 states and in 88 countries. They stand inside Los Angeles police stations and at New York City subway stops, at prisons in Wisconsin and hospitals in Ireland, at a refugee camp in Uganda and a schoolyard in South Sudan.

After his death, the organization requested that "stewards" tie a silver or white ribbon around their libraries in his honor. https://www.mprnews.org/story/2018/10/18/little-free-library-creator-todd-bol-dies


